1350 – 1510 Panel 3: Will the trickle surge? – Charting Asia-Latin America Financial Flows

Strong macroeconomic management, capital market development, deep structural reforms and a period of robust economic growth have created a conducive environment in Latin America for global investors. Asian investors have begun to explore these opportunities although current flows are still relatively small.

This session will discuss:

- What are the key factors underpinning investor interest in Latin America? What regional differences across Latin American capital markets should be understood?
- Which Asian markets have been participating most actively in Latin America? What diversification opportunities does Latin America offer to Asian investors? What should Asian investors do to equip themselves to better assess these opportunities?
- Latin American public and private sector issuers have been increasingly active in tapping Asian capital markets. What is driving their Asia-based funding strategies? What are the emerging trends for Latin American issuers in Asia, in terms of debt, equity, issue size and issue structure?
- Brazil experienced a significant increase in interest from global financial investors, which has since moderated. What is the outlook for Brazilian assets?
