

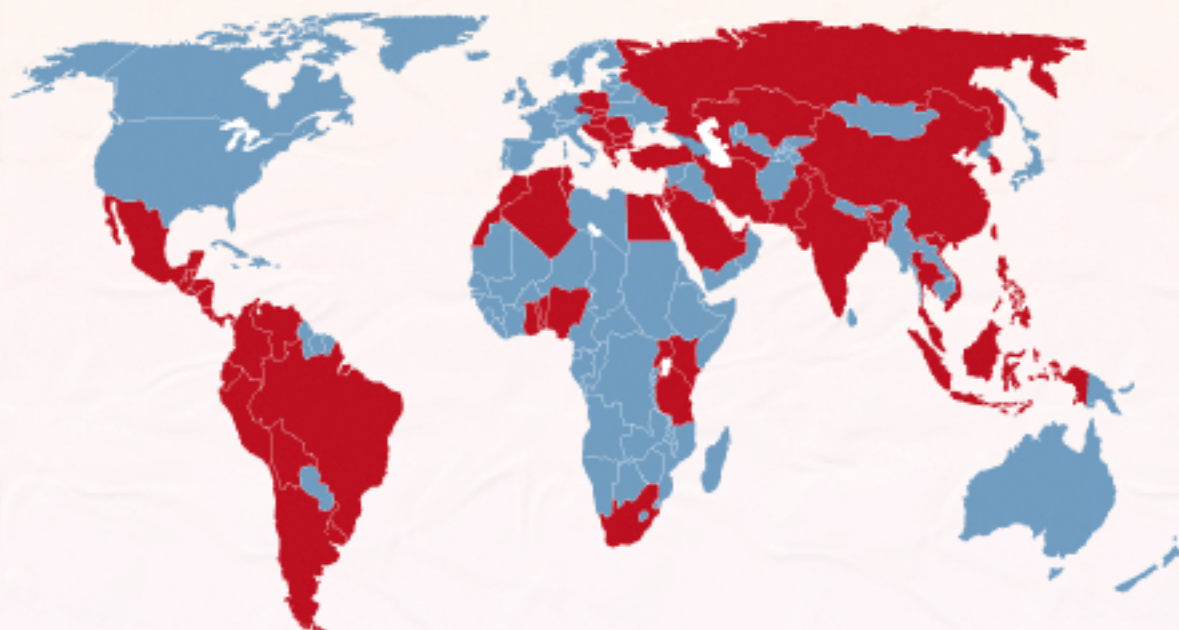

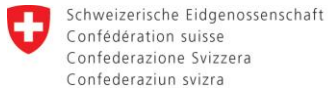

Situated on the expansive square opposite the Mausoleum, the 44-metre tall Hassan Tower, which stretches out above Rabat, is one of the country's national symbols.

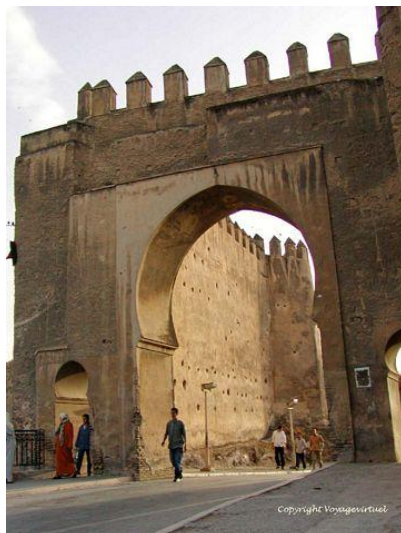


FEZ
