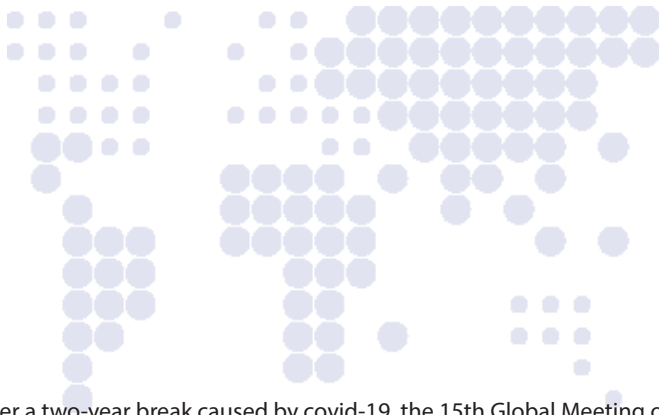

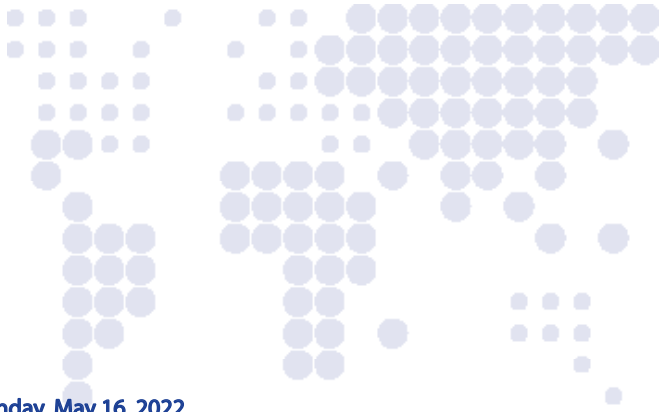

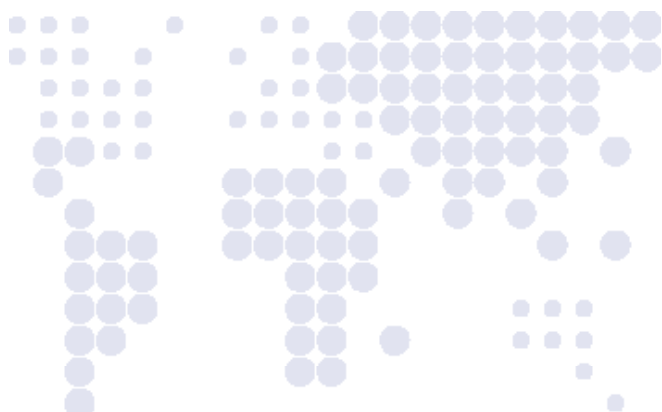

The closest underground station to the hotel is Richelieu-Drouot (line 8 and 9).

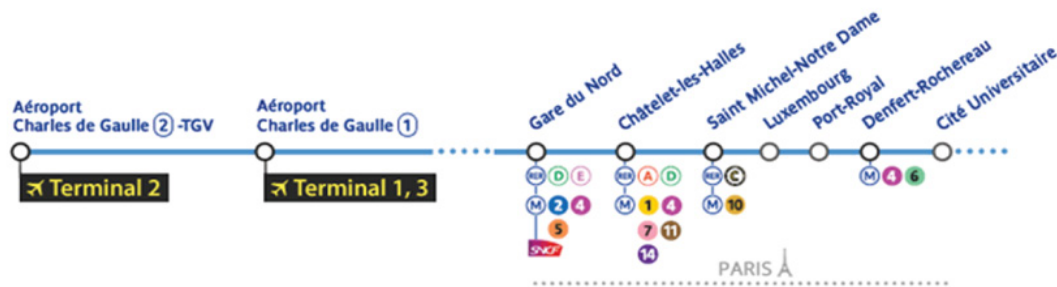
How to get to the Westin hotel:

From Roissy Charles de Gaulle Airport, every day from 5h00 in the morning to midnight, the train RER B can be taken to the station Châtelet les Halles (train every 6 to 15 minutes). It takes around 45 minutes. Tickets can be purchased at the automatic ticket machines in the RER station (10,30 euros a ticket). From Châtelet les Halles, you can reach the centre of Paris by underground (line 1, 4, 7, 11, 14).



By taxi, it takes an hour or more depending on the traffic conditions. Flat fare is around 53 or 58 euros.

From the Orly Airport, it takes around 35 minutes by train (Orlyval train and then RER B train) until the station Châtelet les Halles to reach the centre of Paris. There are daily trains from 6h00 to 23h00 every 4 to 8 minutes from the airport until Anthony station with Orlyval and then from 5h00 in the morning to midnight, every 6 to 15 minutes with the RER B. The special ticket (Orlyval + RER B) costs 12,10 euros and then a metro ticket is 1,90 euros.

By taxi, it takes between 25 to 45 minutes depending on the traffic conditions. Flat fare is 32 or 37 euros.

From any main train stations (Gare du Nord, Gare d'Austerlitz, Gare Saint Lazard, Gare de l'Est and Gare de Lyon), either the underground lines or RER trains can be taken to reach the centre of Paris.

Registration

Upon arrival at Banque de France, participants will be able to register at the Emerging Markets Forum registration desk on 16 May from 8h15 onward. They will receive the final program, the participants' profile and a copy of the book "Envisioning 2060: Opportunities and Risks for Emerging Markets" as well as their badge.

Program

The program has been designed to allow maximum interaction among participants. Each session will be run by a chair who will ensure that the debate remains focused and integrates as many comments and reactions as possible from participants. To stimulate the discussions, participants will receive via e-mail the link to the final program, participants' profiles and a short presentation of the book "Envisioning 2060: Opportunities and Risks for Emerging Markets" at least one week before the start of the Forum.

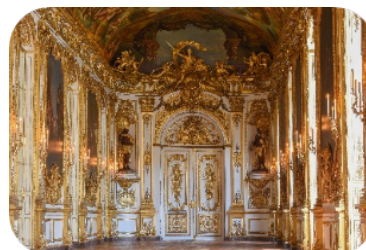
Language

Dress Code

We suggest business casual wear for all sessions.

Participants will be able to wear more formal or national dress in the evening for dinner.

Visa

We advise participants to contact the embassy or consulate of France in their country of origin to check whether they will need a visa.

Covid

Most restrictions were lifted in France since 14 March 2022. Masks are optional on the streets and most indoor venues. Exceptions are medical establishments such as hospitals, nursing homes as well as public transport and planes.

The Vaccine Pass is no longer needed to enter restaurants, cafes, bars, cinemas, museums, theme parks and ski lifts. A Health Pass (proof of vaccination or a negative PCR/antigen test if you are not fully vaccinated) is still needed to enter nursing homes and hospitals.

Upon arrival at the airport in France, you may be asked to show a vaccination certificate or to present a negative PCR test less than 72 hours or an antigen test less than 48 hours if you are unvaccinated.

Since the situation may evolve, prior to your departure for Paris, please check with your airline the latest conditions for travel from your country to France and conform to those conditions.

About the Emerging Markets Forum



Background

The Emerging Markets Forum (EMF) is a not-for-profit initiative that brings together high-level government and corporate leaders from around the world to engage in dialogue on the key economic, financial and social issues facing emerging market countries. The Forum is committed to bridging the gaps across countries through knowledge sharing, policy debate and private-sector engagement to facilitate their common goal of sustainable growth and development.

Many countries are implementing strategies that will lead to faster economic growth and social progress through prudent macroeconomic management, economic liberalization, openness to global markets and support for a dynamic domestic private sector. EMF aims to enable leaders from these countries to engage in a candid exchange of views with their peers in a private and intimate setting. The Forum focuses on substantive discussions of common issues and on reaching actionable solutions and conclusions which can then be disseminated and applied by the participants in their respective countries and organizations.

Major themes of recent meetings include: the impact of the global financial crisis on different groups of emerging market economies, trade and investment, international financial flows; private sector participation in infrastructure development and climate change. The Swiss government provided seed funding for its first meeting, and EMF is now funded by various international institutions and private corporations from both developing and developed nations.

EMF differs from seemingly similar forums as it:

- Has an agenda driven by the priorities of emerging market countries;
- Is predicated on the belief that sustainable development, job creation and poverty alleviation ultimately depend mainly, although not exclusively, on long-term growth and joint efforts of the private and public sectors;
- Draws together participants with first-hand experience: top political leaders, policy formulators and private sector executives;
- Holds meetings small enough (70–90 participants) to permit candor and intense dialogue and yet large enough to incorporate diverse viewpoints;





- Grounds its deliberations in substantive papers written by field experts with first-hand experience in policy formulation; and
- Focuses on practical actions designed to resolve priority issues.

The permanent Co-Chairs of the Global Forum are Michel Camdessus, former Managing Director of the International Monetary Fund (IMF); Enrique Garcia, Former President and Chief Executive Officer of the Development Bank of Latin America (CAF); JIN Liqun, President and Chairman of the Board of Directors, Asian Infrastructure Investment Bank (AIIB); Masatsugu Asakawa, President of the Asian Development Bank (ADB); Hiroshi Watanabe, President of the Institute for International Monetary Affairs; and Marta Lucia Ramirez, Vice President and Minister of Foreign Affairs of Colombia.

EMF has hosted 34, 13 global and 21 regional, to date. Past Forum gatherings have attracted current heads of governments from a number of nations, including Indonesia, Colombia, Kazakhstan, Vietnam and Côte d'Ivoire, and former heads of state from Bangladesh, Bolivia, Burkina Faso, Canada, Ecuador, Mexico, Mozambique, Pakistan, Philippines, Tanzania, and Switzerland.

In addition, economic policy makers, current and former Ministers of Finance, Economy, Industry and Trade as well as Central Bank Governors of some 40 countries in Asia, Europe, Africa and Latin America have participated in the Forum. Top officials of international organizations including the International Monetary Fund (IMF), World Bank, Asian Development Bank (ADB), African Development Bank (AfDB), Development Bank of Latin America (CAF), European Bank for Reconstruction and Development (EBRD), Japan Bank for International Cooperation (JBIC), Japan International Cooperation Agency (JICA), Inter-American Development Bank (IDB), UNDP and UN Economic Commissions for Latin America and Africa have also joined the dialogue. Typically about one-third of the participants are CEOs or Directors of major companies and banks from developed and developing nations. Finally, a select group of heads of independent think-tanks and research institutions, leading journalists and opinion-makers are invited.

The structure of this Forum is unique. The design is informal, with much of the time allocated for free-flowing debate. Session Chairs will be brief in their remarks and they and the discussants together will give just enough input to stimulate subsequent debate. The guidelines are simple: minimize prepared remarks, observe the Camdessus Code of “Conversation not Monologue,” and voice your thoughts, your concerns, and your solutions.

We will share the conclusions reached and ideas generated at the Forum with larger audiences. We intend to publish an account of our proceedings on the EMF website in a summarized report. We will also issue relevant news release(s) and place opinion editorials on topical issues in select media. We will also use social and digital media to communicate key messages and highlights of discussions.

To ensure the accuracy of the account, we will make an audio recording of the proceedings. However, the recording will not be used for any other purpose.

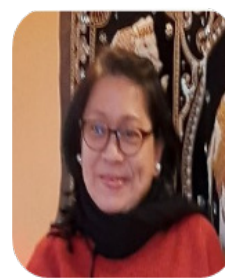
